The Member Care Provider provides care and support for ministry leaders and cross cultural workers overseas by hosting debriefs for workers, planning respite retreats and leading care teams throughout the year. They will recruit volunteers for short term service trips and prepare teams for trips including providing cultural background education, debrief training and prayer ministry training. Once returned stateside, they will debrief team members from the short term trips. The Member Care provider will need to be trained in debriefing to host organization and individual debriefs for workers and their teams/organizations/churches. Assist in pastoral care and provide missionary care for workers under Chosen Vessels' care. Assist in raising support for the overall mission of Chosen Vessels. Recruit and engage in donor care and connection. Encourage, equip and empower leaders around the globe in ministry.
